ALSAC / St. Jude Children's Research Hospital® 2025 Dick Hiley St. Jude Bass Classic Sweepstakes Rules

The **2025 Dick Hiley St. Jude Bass Classic Sweepstakes** is a volunteer-based fundraising program conducted by American Lebanese Syrian Associated Charities, Inc. ("ALSAC") to benefit St. Jude Children's Research Hospital[®] ("St. Jude"). These Rules apply to all participants. The Sponsor (defined below) shall make all determinations as to whether the Rules have been complied with, and the decision of the Sponsor as to any issue is final.

Sponsor: ALSAC/St. Jude is the Sponsor of this Sweepstakes.

<u>Eligibility</u>: NO PURCHASE IS NECESSARY TO PARTICIPATE IN THE SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE A PARTICIPANT'S CHANCES OF WINNING. Participation is open only to legal residents of the 50 United States or the District of Columbia who are 18 years of age or older as of the date of entry. For this purpose, "immediate family" includes the spouse, parents, grandparents, great-grandparents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This definition also includes a) "step" and adoptive relationships, b) individuals for whom an employee is the current legal guardian and c) individuals who are not legally related but who reside with an employee.

<u>Time</u>: The Sweepstakes starts on January 22, 2025 at 12:00 a.m. Central Standard Time and ends on May 2, 2025 at 4:00 p.m. Central Standard Time (the "Sweepstakes Period"). All entries must be received during the Sweepstakes Period to be eligible to win the Prize.

Entry: Participants may enter the Sweepstakes during the Sweepstakes Period by either:

- Donating or fundraising two thousand five hundred dollars (\$2,500) to St. Jude by signing up for a team page or individually donating at <u>https://fundraising.stjude.org/site/TR/Events/Events?fr_id=157183&pg=entry</u>; or

Only one (1) entry per person. For team fundraising pages, the initial \$2,500 will allow the captain of the page to be entered and if the page raises at least \$5,000, then the co-captain will also receive an entry into the Sweepstakes. The odds of winning the Sweepstakes depend on the total number of eligible entries. By participating in the Sweepstakes, each participant fully and unconditionally agrees to, and accepts these, Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes.

<u>Prize</u>: The prize is a Skeeter ZX200 boat("Prize"). There will be one (1) Prize awarded. The approximate fair market value of the Prize is seventy thousand five hundred dollars (\$70,500.00). The actual value may be more or less. The difference in value as stated herein and value at the time of Prize notification, if any, will not be awarded in cash or otherwise. The Prize is non-transferable. Prize may not be redeemed for cash value.

<u>Determination of Winner</u>: There will be one (1) winner ("Winner") of the Sweepstakes. The winner will be chosen by random selection from the Sweepstakes participants who satisfy the entry requirements above. The Winner will be determined on or around May 4, 2025 and announced during the weigh-in for the Dick Hiley St. Jude Classic, located at Izaak Walton Park, 5th Grant Blvd., Wabasha, MN 55981. If the Winner is not in attendance for the announcement, ALSAC staff will contact the winner by phone on May 5, 2025. The selection of the Winner by the Sponsor is final and binding on all participants. The Winner does not need to be present to win.

The Prize may be forfeited and awarded to an alternative winner if the Winner does not respond within two (2) days of notification being sent to such Winner.

<u>Taxes</u>: The value of the Prize is includible in the Winner's income. ALSAC is required to report the value of the Winner's prize to the Internal Revenue Service. The Winner agrees to provide his or her valid name, address, and Social Security number to ALSAC for tax reporting purposes. The Winner is responsible for paying all federal, state, and local income and other applicable taxes that are due in connection with receipt of the Prize.

<u>Additional Agreements</u>: The Winner will be required to execute a Winner Notification Agreement with ALSAC/St. Jude as a condition of accepting his/her Prize. The agreement includes releases of liability in favor of ALSAC and St. Jude.
